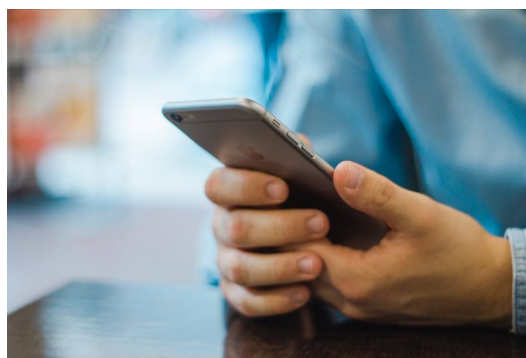

**Ingredients:**

- 2 cups fresh blueberries, raspberries, strawberries and sliced bananas, mixed

- 8 popsicle molds or 8 small paper cups
- 8 popsicle sticks

**Directions:**

1. Place the mixed blueberries, raspberries, strawberries, sliced bananas, yogurt, and sugar into a blender. Cover, and blend until fruit is
